Please be sure to remember these important dates:

- **Friday, July 7<sup>th</sup>**: The application and initial deposit is due
- **Friday, August 4<sup>th</sup>**: the balance of your fee is due
- **Thursday, August 31<sup>st</sup>**: Tent setup begins at 6pm

Also, please be sure to obtain your onsite health permit with the McHenry County Health Department BEFORE you arrive for set-up beginning August 31<sup>st</sup>. You can contact the Health Department at **815.334.4510**. The permit fee is not included in the vendor fee and must be handled directly with the Health Department.

Your fees and application can be mailed to the Summer Sunset Committee at 600 Harvest Gate. Lake in the Hills, IL 60156. By submitting your application via email, you will still be responsible to make payment on time.

### Food Vendor Regulations

1. All vendors are responsible for obtaining a valid McHenry County Health Department permit. For applications, contact the Health Department at (815.334.4510). The permit fee is NOT included in the vendor fee and must be handled directly with the Health Department.
2. All vendors must supply a valid certificate of liability insurance in the amount of \$1,000,000 with the Village of Lake in the Hills and the Summer Sunset Festival as additional insured.
3. Food vendor fee: \$600.00 + \$100.00 refundable clean-up deposit.
4. Food court will be open on Friday (3:00pm-10:30pm), Saturday (11:00am – 10:30pm) and Sunday (11:00am-10:30pm) during the festival. Vendors may set-up Thursday at 6:00pm.
5. OPTIONAL PARADE HOURS: Vendors can open as early as **9:30am on Saturday** to take advantage of the parade crowd.
6. All vending stands must be staffed during food court hours.
7. **\$400 deposit** (which includes the \$100 refundable deposit) is required by Friday, July 7<sup>th</sup>, 2016. The balance of **\$300.00** is due by Friday, August 4<sup>th</sup>, 2016.
8. The \$400 deposit is non-refundable after Friday, July 8<sup>th</sup>, 2016 if the vendor decides not to participate.
9. All vendors are responsible for cleaning their area following the festival. If the festival committee deems that the vendor did not adequately clean, the vendor's clean-up fee of \$100 will not be returned. Any applicable deposit due back to vendors will be processed within in 30 days of the closing of the festival.
10. All checks should be made payable to the **Village of Lake in the Hills**.
11. Vendors are responsible for damage to any items supplied by the festival including, but not limited to, tents, tables, chairs and lights.
12. **All vendor items, including food, drinks and pre-packaged goods, must be approved by the food vendor committee.**
13. **The food vendor committee will limit the number of duplicate food items served to provide a wide variety of food options and to protect vendor sales of unique items.**
14. Beverages: all vendors **will** be allowed to sell pre-packaged beverages including plain bottled water, juice, soda, sports drinks, vitamin water, energy drinks, etc. Please be aware these items may be duplicated by multiple vendors.
15. Beverages: sale of all other drinks not listed here will be at the discretion of the food vendor committee.
16. Ice will be provided for purchase at the festival from the Sunset Fest Committee.
17. The festival will supply access to non-potable water.
18. Vendors are responsible for supplying appropriate extension cords for electrical items.
19. Vendors are responsible for ensuring that their equipment meets local fire codes. Inspection will be performed on Friday prior to festival open.
20. Each vendor will be provided with 4 standard electrical outlets for use at the fest. IF ANY other specialty electrical outlets are needed, a **\$35.00 fee** per outlet will be charged. You **MUST** list on the application all your electrical needs. Last minute requests will not be granted.
