2017 Winery Information

- Festival Date:** Saturday, Sept. 2 and Sunday, Sept. 3 (Rain or Shine)
- Location:** Sunset Park (5200 Miller Rd., corner of Miller and Haligus roads in Lake in the Hills)
- Hours of Operation:** Saturday and Sunday: 4:00pm -10:30 pm (Setup between 3pm-4pm)
- Booth Specs:** Wine tasting tent is at least 30' x 90'
Each booth space under the tent is 10' wide x 5' deep, backing up to a back wall
2 – 8' x 30" tables
2 – folding chairs
Electrical needs must be communicated on your application
- Winery Fees and Benefits:** \$175 (non-refundable) per single booth, made payable to the **Village of LITH**. Fee includes 2 days of electric (must notify festival of needs in advance), trash removal, tables and chairs, ice, black linen table skirting, applicable Village of LITH temporary permit for the sale of alcohol fees, and marketing on multiple websites, newspaper ads, and area signage. Each winery is also required to independently apply for a Special Use Permit for the State of Illinois. Once the wine tasting application and fee are submitted to LITH, we will send our local permit to you so you can obtain the State Special Use Permit. Each winery will receive \$0.65 per ticket reimbursement from their booth's tastings, which will be mailed to them via check no later than 30 days following the festival.
- Festival Information:** The Wine Tasting event is part of the annual Summer Sunset Festival, which draws thousands of attendees each day for the free live music, carnival rides, food booths, kids' activity tent, 5k race, Baggo tournament, parade, fireworks, car show and talent contest. For a \$10 entry fee per person per day to the fenced wine tasting area, wine tasters will get a souvenir wine glass, bracelet, and five (5) tasting tickets. Additional tickets will be available for \$1.00 each. Each winery may bring as many wines/meads as they wish and may sell by the glass, bottle or case. Open containers or glasses will be allowed to leave the wine tasting area but CANNOT leave the festival grounds. Sales of wine by the glass or bottle cannot be made to the general public—only to the festival goers who have a bracelet indicating that they are 21 or older and have the special Wine Tasting glass.
- Security:** Uniformed patrol officers provided by the Village of Lake in the Hills Police Department will patrol during the festival. However, this in no way implies responsibility on the part of the Village of Lake in the Hills for lost/stolen items. Overnight surveillance of the wine tasting tent will be provided by two hired security individuals so that you may leave your inventory overnight if you choose.
